TRAINING LOCATION: CMI conducts the training in its building located in Schertz, Texas at: 6704 Guada Coma, Schertz, Texas 78154 (Map & hotel listing is attached).

IMPORTANT NOTICE:

Class times are from 8:00 AM until 5:00 PM on Thursdays. If a BAT Instructor has already been trained as a BAT, he/she will still need to participate in the BAT training class in order to ensure he/she is proficient in the current DOT guidelines (49 CFR Part 40). These classes are task oriented courses and the duration of class times may vary depending on factors such as: number of instruments available for training, the level of proficiency demonstrated by the various students, and the number of students participating in the class. The class time will not exceed 8:00 to 5:00 each day, however the classes may be dismissed earlier. Discounts will not be provided for early dismissal.

COURSES:

Breath Alcohol Technician (BAT) - This certification allows the technician to perform D.O.T. breath alcohol testing on any person.

BAT Instructor - This certification allows the instructor to train other employees of the instructor's company as B.A.T.'s. The Instructor Agreement and Licensing Agreement must be signed and turned in before Certification.

Breath Alcohol Technician Refresher Training - This training must be done every five years to renew certification.

Instrument-Only Training - This training is for individuals who are already BATs and just need training on the instrument.

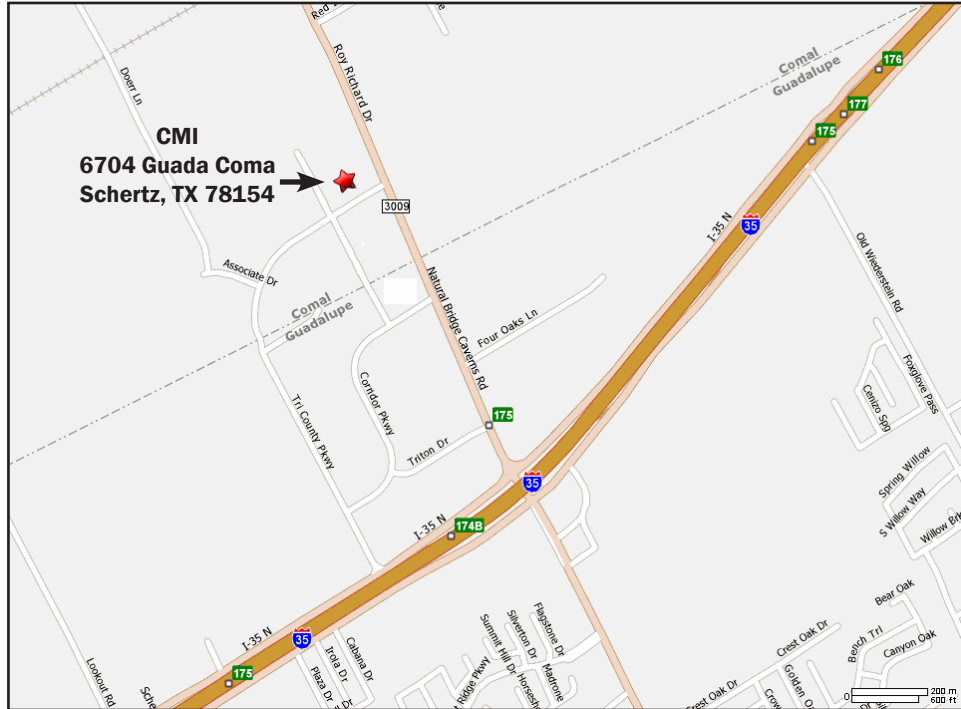
